The actual report on the beneficiaries by Gram Panchayats, (village level institution) is available in our portfolio which shows that the actual improvement is not taking place, in enhancing livelihood opportunities. There are evidences available which shows that water harvesting measures, rejuvenation and development of water sources, treatment of catchment area through watershed treatments and village development, is not taking place as per the monitoring plans. The participatory watershed development and management component is not being implemented as per the original appraisal plans therefore the community people are likely to suffer. We shall be glad to provide the details on the omissions that are of concern to the people in our subsequent letters.
